

**BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID
AND RECOMMENDING AWARD OF CONTRACT**

Resolution No. 30, s. of 2017

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee (BAC), posted the Invitation to Bid for the bidding of the Supply of Laboratory Equipment consisting of six (6) lots with an approved budget of Three Million Sixty Six Thousand Pesos only (P3,066,000.00) in the PhilGEPS website, in UP Mindanao website, and in a conspicuous place in the premises of UP Mindanao continuously for seven (7) days; however, the total budget was reduced to P2,766,000.00 since Lot 6 with approved budget of P300,000.00 was deleted per Bid Bulletin 01-2017;

WHEREAS, as a result of such postings two (2) bidders, namely, Instrumix Supplier Inc. and Yana Chemodities, purchased bid documents and submitted their bids upon the deadline for submission on December 12, 2017;

WHEREAS, after the preliminary checking of the eligibility and technical requirements the two bidders were both found to be eligible for bidding;

WHEREAS, upon opening of the financial envelopes the bids were read as follows:

NOW, THEREFORE, we, the members of the Bids and Awards Committee hereby resolve the following:


