

BAC RESOLUTION DECLARING LCRB AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, after two failed biddings the University of the Philippines Mindanao, through its Bids and Awards Committee, posted the Notice for Negotiated Procurement of the Supply of Software, Computer, Printer, Copier, GPS, Fixtures & Furniture, Appliances and Other Equipment with an approved budget of Three Million Seven Hundred Fifty Four Thousand Pesos Only (P3,754,000.00) in the PhilGEPS website, in the UP Mindanao website, and in a conspicuous place in the premises of the University of the Philippines Mindanao continuously for seven (7) days;

WHEREAS, as a result of such postings five (5) bidders submitted their price quotations and other requirements upon the deadline on 8 December 2016;

WHEREAS, upon preliminary checking of the required documents consisting of SEC Registration, Mayor's Permit, Audited Financial Statement, NFCC, Technical Specifications, Bid Form and Certificate of PhilGEPS Registration all of the five bidders were found eligible for bidding;

WHEREAS, upon opening of the financial proposals the bid prices were read as follows:




