

**BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID AND
RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY OF IT EQUIPMENT**

Lots 9, 11, and 21

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee (BAC), published the Invitation to Bid of the Supply of IT Equipment 2nd Bidding with total approved budget amounting to P23,553,900.00 consisting of twenty three (23) lots, in the Manila Bulletin and posted the same on the PhilGEPS website, the UP Mindanao website, and in a conspicuous place in the premises of the University of the Philippines Mindanao continuously for seven (7) days;

WHEREAS, as of the opening of bids on April 6, 2017 four bidders submitted their bids but only three (3) were found to be eligible for bidding, namely: Emcor Inc., Ng Khai Corporation, and S1 Technologies;

WHEREAS, upon opening of the financial proposals, the following were the bids as read:

WHEREAS, upon thorough evaluation and post qualification of the technical specifications submitted by the following bidders for the lots indicated, their respective bids were found to be the compliant and responsive, to wit: Ng Khai Corp. for Lot 9; Emcor Inc. for Lot 11, and S1 Technologies for Lot 21; however, the bid of Emcor Inc. for Lot 20-SOM IT Equipment and Peripherals was found to be non-compliant and non-responsive to the specification for Item 7-Smart TV;

NOW, THEREFORE, we, the members of the Bids and Awards Committee hereby resolve to recommend them for award of the contract for the Lots 9, 11, and 21 to the above-named bidders;


