



BAC-INFRA Resolution No. 03 s. of 2023

BAC RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (DEVDEX CONSTRUCTION SERVICES) FOR THE REBIDDING OF IMPROVEMENT OF MULTI-PURPOSE BUILDING, UP SPORTS COMPLEX, UP MINDANAO, DAVAO CITY (PBM 2023-29)

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee (BAC) for Infrastructure posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days the Invitation to Bid of the Rebidding of Improvement of Multi-Purpose Building, UP Sports Complex, UP Mindanao, Davao City (PBM 2023-29) with the approved budget for the contract (ABC) amounting to Fifteen Million Pesos (P15,000,000.00);

WHEREAS, as a result of such postings there was only one (1) bidder that submitted its bids upon the deadline for submission on December 4, 2023 – Devdrex Construction Services;

WHEREAS, after the preliminary checking of the eligibility and technical envelope of the lone bidder, the BAC found their bid, eligible;

WHEREAS, upon opening and checking of the financial envelope, the bid price of Devdrex Construction Services amounting to Thirteen Million Four Hundred Ninety-Nine Thousand Seventy-Six Pesos and Eighty Centavos (P13,499,076.80) was found to be within the Approved Budget for the Contract;

WHEREAS, the documents submitted were forwarded to the Technical Working Group (TWG) for further evaluation, to ensure the completeness of the bid and apply arithmetical corrections. It was found that Devdrex Construction Services' bid as read and as computed are not the same, as shown in the table below.

WHEREAS, based on the submitted documents, the bid amount as read shall prevail since it is lower. Moreover, the TWG's findings showed that the Bill of Quantities (BOQ) format submitted by the bidder is different from the prescribed format from the Terms of Reference. However, their bid was declared as the Single Calculated Bid since the itemized bid price can be found in their Detailed Price Estimate Form;

WHEREAS, as a result of the post-qualification conducted by the TWG for the documents submitted by Devdrex Construction Services, their bid was found compliant;

NOW THEREFORE, we the members of the Bids and Awards Committee for Infrastructure hereby **RESOLVE** as it is hereby **RESOLVED** the following:

- 1) To declare Devdrex Construction Services as the Lone or Single Calculated and Responsive Bid (SCRB) for the Rebidding of Improvement of Multi-Purpose Building, UP Sports Complex, UP Mindanao, Davao City (PBM 2023-29); and
- 2) To recommend for approval of Chancellor Lyre Anni E. Murao the award of the contract to Devdrex Construction Services in the amount of Thirteen Million Four Hundred Ninety-Nine Thousand Seventy-Six Pesos and Eighty Centavos (P13,499,076.80).
