BAC Resolution No. 37 s. of 2023

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID FOR THE REBIDDING OF THE SUPPLY AND DELIVERY OF MATERIALS FOR THE OPERATIONALIZATION OF FACE-TO-FACE CLASSES (PBM 2023-31)

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days, the Invitation to Bid of the Rebidding of the Supply and Delivery of Materials for the Operationalization of Face-to-Face Classes with project identification no. PBM 2023-31. The procurement project consists of eighteen (18) items with a total approved budget for the contract (ABC) amounting to P3,647,908.00, to be awarded on a per-item basis as stated in the bidding documents;

WHEREAS, as a result of such postings, one (1) bidder, Prince Educational Supply, purchased bid documents and submitted their bid upon the deadline for submission of bids on December 27, 2023;

WHEREAS, after the opening and preliminary examination of the technical envelope requirements, the BAC declared the lone bidder to be eligible for bidding;

WHEREAS, upon opening and preliminary checking of the financial envelope requirements of Price Educational Supply, the BAC read the following bids as shown in the table below:
