BAC Resolution Declaring Highest Rated Bid and Recommending Award

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee, posted the Request for Expression of Interest of the Design Services for the Construction of CARIM Building Phase 2 (2nd bidding) with an approved budget of One Million Six Hundred Twenty Thousand Three Hundred Seventy and 37/100 Pesos Only (P1,620,370.37), in the PhilGEPS website, UP Mindanao website, and in conspicuous places in the University premises for seven days;

WHEREAS, in response to the said advertisements two (2) bidders, A.C. Ong Consulting and DM Briones Construction Enterprises submitted their applications for eligibility and upon checking their eligibility documents both bidders were found eligible;

WHEREAS, in accordance with Section 24.5 of the Implementing Rules and Regulations of RA 9184, the shortlisting was conducted with only the two bidders in the short list;

WHEREAS, upon detailed evaluation of the technical and financial proposal and calculation of scores using the Quality Cost Based Evaluation Procedure (QCBE) with 70% for Technical Proposal and 30% for Financial, the following is the ranking of the two bidders:



NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve to declare DM Briones Construction Enterprises as the Highest Rated and Responsive Bid (HRRB) for the Design Services of the Construction of CARIM Building Phase 2 at a contract price of Seven Hundred Eighty Eight Thousand Eight Hundred Four Pesos Only (P788,804.00) and to recommend the award of the contract to DM Briones.
