

BAC RESOLUTION
No. 2015-27

WHEREAS, the University of the Philippines Mindanao, published the Invitation to Bid for the 2nd bidding of the Supply of Branded GNSS Survey Equipment, Spectrometer, Workstations, and other Equipment for LiDAR Project with a total approved budget of Seven Million Three Hundred Eighty Five Thousand Pesos Only (P7,385,000.00) in the Manila Bulletin and posted the same in the PhilGEPS website, UP Mindanao website and in a conspicuous place in the premises of the University of the Philippines Mindanao continuously for 7 days;

WHEREAS, in response to the said postings, seven (7) bidders purchased bid documents and submitted their bids on July 14, 2015;

WHEREAS, upon preliminary checking of the eligibility and technical documents submitted by the seven bidders, only four (4) bidders were declared eligible for bidding, namely: Fil-Anaserve, Inc., Geodata Systems Tech, Inc., GlobalChips Technologies, and RASA Surveying;

WHEREAS, after opening of the financial proposals the following were the bid prices offered:

WHEREAS, upon a thorough evaluation of the technical and financial documents submitted, the Bids and Awards Committee found the bids submitted for the following items to be compliant: Item No. 3-Spectrometer submitted by Fil-Anaserve, Inc. and Item No. 12-UPS submitted by GlobalChips Technologies, Inc.; however, the bid of GlobalChips for Item 11-Branded Desktop Computers was above the approved budget so it was disqualified while all the bids for the other items were found to be non-compliant to the specifications;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve the following:

1. To declare Fil-Anaserve, Inc. as the winning bidder for Item 3- Fiber Optic Spectrometer with its bid amounting to P1,298,000.00;
2. To declare GlobalChips Technologies, Inc. as the winning bidder for Item 12- UPS with its bid amounting to P179,100.00; and

3. To declare a second failure of bidding for the rest of the items and recommend that negotiated mode of procurement be resorted to.
