WHEREAS, the University of the Philippines Mindanao published the Invitation to Bid of the Supply of Branded GNSS Survey Equipment, Fiber Optic Spectrometer, Workstations and other Equipment for the Lidar Project with a total approved budget of Seven Million Five Hundred Eighty Five Thousand Pesos Only (P7,585,000.00) in the Manila Bulletin and posted the same at the PhilGEPS website, UP Mindanao website and in a conspicuous place in the University premises continuously for 7 days;

WHEREAS, in response to the said advertisements four (4) prospective bidders purchased bid documents and submitted their bids on May 18, 2015;

WHEREAS, upon checking of the eligibility and technical requirements of the four bidders two bidders were disqualified due to lacking documents and only two bidders, Fil-Anaserve Inc. and GlobalChips Technologies CDO Inc., were found to be eligible;

WHEREAS, upon opening of the financial bids of the two eligible bidders their bids were read as follows:

WHEREAS, after thorough evaluation of the bid submitted by Fil-Anaserve, the lone bidder for the Spectrometer, its bid was found to be non-responsive and non-compliant to the specifications;

WHEREAS, after thorough evaluation of the bid submitted by GlobalChips Technologies for Item 4-Workstations and Item 8-Full Rugged Laptop, its bid was found to be non-responsive and non-compliant to the specifications while its bid for Item 12-Branded Desktop Computers was above the approved budget and was therefore automatically disqualified;



To recommend a second bidding for the following items: Branded GNSS Survey Equipment; Dual Frequency RTK GPS, Spectrometer, Workstations, Branded Total Station; Hand Held GPS, Full Rugged Laptop, Personal Computers, Desktop Computers, Laptop Computer, Branded Desktop Computers, UPS 10 KVA and UPS 720W.
