

BAC RESOLUTION

WHEREAS, the University of the Philippines Mindanao, published the Invitation to Bid of the Supply of Equipment for the CHSS Cultural Complex with an approved budget of Five Million Pesos Only (P5,000,000.00) in the Manila Bulletin, a newspaper of nationwide circulation; posted the same in the PhilGEPS website, in the UP Mindanao website, and in a conspicuous place in the premises of the University of the Philippines Mindanao continuously for 7 days;

WHEREAS, in response to the said advertisements, one bidder, Better Components, Inc., purchased bid documents and submitted its bid on December 10, 2015;

WHEREAS, upon preliminary checking of the eligibility and technical documents submitted by the lone bidder it was declared eligible for bidding;

WHEREAS, upon opening of the financial proposal submitted by Better Components, Inc. its bid was read as follows:

WHEREAS, upon a thorough evaluation and post qualification of the eligibility, technical and financial documents submitted by Better Components, Inc. for Lots 4 and 8, the bids for both Lots 4 and 8 were found to be non-compliant to the requirement for bidding;

WHEREAS, upon a thorough evaluation and post qualification of the eligibility, technical and financial documents submitted by the lone bidder for Lot 7 – Soundproofing, its bid was found to be compliant and responsive to the requirement for bidding;

1. To declare Better Components as the single calculated and responsive bid for Lot 7 – Soundproofing and recommend the award of Lot 7 to Better Components, Inc., with its bid amounting to Four Hundred Eighty Thousand Pesos Only (P480,000.00) and
2. To declare a failure of bidding for the other lots and schedule a rebidding.


