

BAC Resolution Declaring LCRB and Recommending Approval

BAC RESOLUTION NO. 2017-11

WHEREAS, the University of the Philippines Mindanao, through the Bids and Awards Committee for Infrastructure Projects, published the Invitation to Bid for Quotation for the Completion of Football Field: Delivery and Installation of Synthetic Track and other Facilities for the University of the Philippines Mindanao with a total Approved Budget for Contract (ABC) of Thirty Five Million Pesos (P35,000,000.00) in newspaper of national circulation and UP Min and PhilGEPS websites continuously for seven (7) days;

WHEREAS, as a result of this publication, four bidders submitted their bids upon the deadline on 8 Sept. 2017, and upon opening of financial component, these were read as follows:

P27,483,884.40

WHEREAS, after thorough evaluation, validation and verification of all the eligibility, technical and financial requirements the quotation submitted, among the four (4) bidders, Firmbuilders, Inc. having the lowest bid did not comply with the following requirements of Bid Bulletin No. 06 dated 31 August 2017:

- a) technical specifications on the HDPE seats; and
- b) use of the prescribed Unit Price Analysis Template (UPA) which specifies the computation for customs duties;

WHEREAS, the result of the said evaluation, FIRMBUILDERS, Inc. is found to be non-compliant;

WHEREAS, the bid of SPURWAY Enterprises in the amount of Twenty Five Million Five Hundred Twenty Two Thousand Six Hundred Fifteen Pesos & 73/100 (P25,522.615.73) as the next Lowest Calculated Bid (LCB) has been found to be responsive;

NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare SPURWAY Enterprises as the Bidder with the Lowest Calculated and Responsive Bid (LCRB) of the Completion of Football Field: Delivery and Installation of Synthetic Track and other Facilities;
- b) To recommend for approval by the Chancellor of the University of the Philippines Mindanao the foregoing findings.
