## BAC Resolution No. 16 s. of 2023

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD OF THE CONTRACT FOR LOTS 2-8 OF THE SUPPLY OF KITS, REAGENTS, CONSUMABLES, COMMON LABORATORY, AND LABELING SUPPLIES OF THE SARS-COV2 BIO-SURVEILLANCE PROJECT OF PGC MINDANAO (PBM 2023-10)

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days, the Invitation to Bid of the Supply of Kits, Reagents, Consumables, Common Laboratory, and Labeling Supplies of the SARS-COV2 Bio-Surveillance Project of PGC (PBM 2023-10) consisting of eleven (11) lots with total approved budget for the contract (ABC) in the amount of P7,321,400.00;

WHEREAS, as a result of such postings six (6) bidders purchased bid documents and submitted their bids upon the deadline for submission on April 24, 2023 consisting of the following:

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by Joelmar Trading, the Lowest Calculated Bid for Lot 1 – Alcohol, their bid was found to be non-compliant and non-responsive to the technical specifications on the grounds that the offered Absolute Ethanol was not molecular grade;

WHEREAS, when the TWG conducted post qualification on the second lowest bidder, Rainbud Scientific Trading Enterprise, it was found that some parts of their bid need clarification since the link provided was not accessible and there were no brochures attached to their bid;

WHEREAS, upon the post qualification and thorough evaluation of the bid documents submitted by the other bidders for Lots 2, 3, 4, 5, 6, 7, and 8, the following were the TWG findings, namely:
