BAC Resolution No. 17 s. of 2023

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD OF THE CONTRACT FOR LOTS 1 and 2 OF THE REBIDDING OF NETWORK MAINTENANCE AND UPGRADE AND IT MAINTENANCE KIT FOR THE SKAI-PINAS ALAM-LSI PROJECT (PBM 2023-12)

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days, the Invitation to Bid of the Rebidding of Network Maintenance and Upgrade and IT Maintenance Kit for the SKAI-Pinas ALAM-LSI Project (PBM 2023-12) consisting of two (2) lots with total approved budget for the contract (ABC) in the amount of P2,450,000.00;

WHEREAS, as a result of such postings two (2) bidders purchased bid documents and submitted their bids upon the deadline for submission on May 9, 2023 at 9:00AM;

WHEREAS, after the preliminary checking of the eligibility and technical envelope requirements the BAC declared the two bidders, R3Hub IT Solutions and Presidium.PH Corporation, to be eligible for bidding;

WHEREAS, upon opening and checking of the financial bids, the BAC read out the following bid amounts, to wit:

WHEREAS, upon the post qualification and thorough evaluation of the bid documents submitted by Presidium.PH Corporation for Lot 2 – IT Maintenance Kit, its bid was likewise found to be compliant and responsive to the technical specifications;

- 1) To declare the bidders listed below as Lowest Calculated and Responsive Bids (LCRB) for the lot indicated, namely:






