BAC Resolution No. 11 s. of 2019

DECLARING RESPONSIVE BID FOR THE SUPPLY OF PCR LAMINAR FLOWHOOD AND DUCTLESS FUMEHOOD FOR THE PHILIPPINE GENOME CENTER (PGC) MINDANAO

WHEREAS the University of the Philippines Mindanao through its Bids and Awards Committee (BAC) posted the Invitation to Bid for the bidding of the Supply of PCR Laminar Flowhood and Ductless Fumehood for the Philippine Genome Center (PGC) Mindanao with an approved budget of P1,050,000.00 in the PhilGEPS website, UP Mindanao website, and in a conspicuous place within the campus for 7 calendar days;

WHEREAS, as a result of such postings five (5) bidders purchased bid documents and all five bidders submitted their bids upon the deadline for submission on August 27, 2019;

WHEREAS, upon preliminary evaluation of the documentary requirements, all the bidders were found to be eligible for bidding;

WHEREAS, upon opening of the financial envelopes the following were the bids as read:

WHEREAS, after thorough evaluation and post qualification of the bids submitted by Krypton Industrial Resources, Fil-Anaserve, Inc., Gilmed Enterprises and Services, and Noveaulab Asia Corp., their bids were all found to be non-compliant and non-responsive to the technical specifications per attached Evaluation Report submitted by the Technical Working Group and after the said non-compliant bidders were notified of the result of the evaluation/post-qualification, no more requests for reconsideration was received within the three-day period from receipt of the BAC's notice;

NOW THEREFORE, we the member of the Bids and Awards Committee hereby resolve to declare Levins International Corporation as the most responsive bid and recommend it for the award of the contract in the amount of P1,039,000.00.
